Roles and Responsibilities of Board Members

We are looking for individuals whose skills, passion and experience align with the RVCF's mission, guiding principles and strategic priorities.

The RVCF Board of Directors provides strategic leadership, governance and oversees the operational and financial performance of the Foundation. Members of the Board bear a fiduciary duty to RVCF, its mission and its supporters. Board Members have the option to serve on one or more standing/ad hoc committees such as Finance, Governance and Membership. In pursuing their duties of care, diligence and loyalty, members are expected to come prepared for meetings, ask questions, actively participate in events and fundraising.

- Engage with key stakeholders including funders, partners, donors and supporters

- Ensure that the resources entrusted to the Foundation further the goals of the Rideau Valley Conservation Authority

- Attend Annual General Meeting from approximately 12:00 to 1:30 p.m. in Manotick, ON
- Able to commit the time and resources to serve on the Board
- Represent RVCF in the community
- Have the ability to serve for a minimum of one (1) year and be eligible for reelection at the annual general meeting
